LOCATION

Cutters Close is accessed via Coventry Road B4114. The area is a mix of residential and industrial properties.

DESCRIPTION

The property comprises a mid-terrace factory/warehouse with single-storey offices section, toilet facilities, electrically operated roller shutter loading door, 10% translucent roof lights plus concrete loading apron.

The main production area is arranged under a single-span steel-portal frame with internal clearance of approximately 6.10 metres. To the front elevation of the property is a single-storey office section which comprises an open plan area with two separate offices off. The office section is fitted to include, air-conditioning, perimeter trucking for power and data cabling, electrical panel heating, surface mounted LED lighting and uPVC double glazing. The factory/warehouse area benefits from, a concrete floor, 3-phase electricity supply and pendant style lighting.

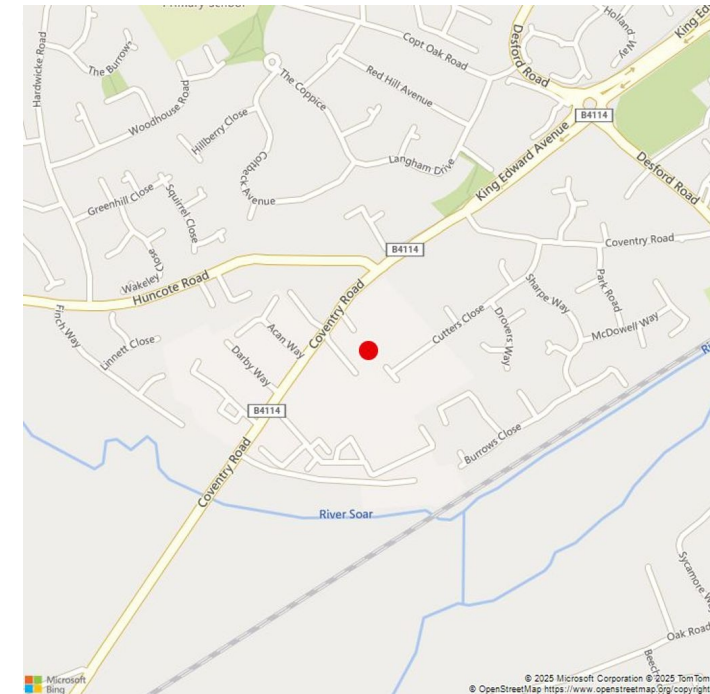
